THE MINISTER OF URBAN DEVELOPMENT (SHRI ABDUL GHAFOOR); (a) Yes, Sir.

- (b) The particulars are given in the Statements I and II laid on the Table of the Sabha. [See Appendix CXXXIX, Annexure No. 32].

- (d) The Statement I [See Appenlix CXXXIX, Annexure No. 327 also includes high-rise buildings belonging to the Government.
- (e) Vikas Minar is one of the buildings without 'No Objection Certificate'.
- (f) and (g) The "Fire Prevention and Fire Safety Bill, 1986" has been passed by the Metropolitan Council of Delhi. It proposes to confer on the Delhi Fire Service additional powers to enforce fire safety measures. Delhi Fire Service has asked the builders/promoters of high-rise buildings to provide safety measures in their buildings within a period of 3 months.
- (h) There are height restrictions depending upon locatlities and usage

of buildings. These are prescribed in the unified building bye-laws.
