## Perfortmance of electrical generating units

655. DR. MOHD. HASHIM KID-WAI: Will the Minister of ENERGY be pleased to state:

(a) whether it is a fact that the performance of some electrical generating units in the country is not satisfactory;

(b) whether it is also **a** fact that this has resulted in the shortfall of power generation in the country; and

(c) if so, what steps the Government propose to take or have taken in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER AND MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRIMATI SUSHI -LA ROHATGI); (a) and (b) During the period April-June, 1986, the total power generation was 1.5 per cent less than the programme. The shortfall was mainly on account <sup>01</sup> poor performance of some of the thermal units and low hydel generation due to low reservoir levels.

(c) The measures taken to increase the availability of power include expediting commissioning of new capacity, better utilisation of existing capacity, implementing short-gestation projects, reducing transmission and distribution losses and implementation of energy conservation and demand management measures.

## Performance of coal companies

657. SHRIMATI RENUKA CHOW-DHURY: Will the Minister of ENERGY be pleased to state:

(a) how many of the subsidiary companies of the Coal India Limited showed better performance in 1985-86; (b) which are the companies under CIL which are showing continuous losses and also not reaching their tar get of production; and

(c) what efforts are being made by Government to improve their perfor mance?

THE MINISTER OF ENERGY (SHRI VASANT SATHE): (a) to (c) Accounts of Coal India Limited and its subsidiaries for the year 1985-86 have not yet been finalised.

While Central Coalfields Limited, Western Coalfields Limited and Central Mine Planning and Design institute Limited have been earning profit since 1979-80, Bharat Coking Coal Limited and Eastern Coalfields Limited have been incurring losses over the years.

During the year 1985-86, both, Central Coalfields Limited and Western Coalfields Limited exceeded the'r targets of production. Eastern Coalfields Limited exceeded the target of production very marginally Bharat Coking Coal Limited, however, lagged behind the target.

Various measures being adopted to increase production and improve productivity in the coal companies include considerable investment in new mines, fuller utilisation of mining capacity already created, more efficient use and better maintenance of equipment, stricter control of inventory and economy in the use of stores, better use of manpower 'by controlling absenteeism and enforcing discipline and identification of surplus workers and their redeployment after suitable training, better availability of scarce inputs like explosives, timber etc., reduction in pit-head stocks by faster movement and more systematic distribution, expeditous and timely completion of new projects- and improve-, ment in law and order situation.

Besides, the performance of the coal companies is reviewed by the Government from time to time and coal com-

panies are advised suitably to take remedial/corrective measures to improve their performance.

The Coal India limited and Eastern Coalfields Limited have been directed to impelement the dicisions of the Government on the various recommendations of the Chari Committee appointed by the Government to enquire into the working of Eastern Coalfields Limited.

Government have appointed a Committee under the Chairmanship of Shri A. N. Banerjee, former Chairman-cum-Managihg Director, Central Mine Planning and Design Institute Limited to enquire into the working of Bharat Colung Coal Limited and suggest remedial measures for improving its performance. The report of the Committee is awaited.

## Improvement in the performance of DESU

(a) whether it is a fact that the Delhi Electric Supply Undertaking' (DESU) could not provide better service due to transmission problems and lack of replacement of cables; and
