The construction of Yatri Niwasses have been approved and funds already released in case of Yatri Niwases at Port Blair, Goa, Kurukshetra, Kancheepuram, Satpada, Palam, Dakrjre, Darjeeling and Jullundhur.

The proposals have been received Irom another 15 States/UTs, which are being processed. The remaining States and UTs are being persuaded to forward their proposal with blueprints and estimates.
