MR. CHAIRMAN: Is it 12 per cent on PPF?

SHRI VISHWANATH PRATAP SINGH: On PPF, it has been 12 per cent. On Employees Provident Fund that has been asked, 85 per cent is invested in special deposits...

MR. CHAIRMAN: No, no. What is the rate of interest of EPF and PPF?

SHRI VISHWANATH PRATAP SINGH: Sir, on PPF, it is 12 per cent and on EPF, 85 per cent deposits are with the Central Government carrying an interest at 12 per cent and balance 15 per cent with the State Government which carries 11 per cent interest. So, 85 per cent of the EPF does carry interest of 12 per cent.

MR. CHAIRMAN: No, no. The point really is: for the beneficiary, the interest for the Employees Provident Fund should not be lower than the interest for the Public Provident Fund.

SHRI VISHWANATH PRATAP SINGH: Sir, I may submit that 85 per cent of the EPF does carry 12 per cent of interest. It is only 15 per cent which is invested in the State Governments, that carries 11 per cent. So 85 per cent does carry 12 per cent interest.

SHRI NIRMAL CHATTERJEE: Sir, your point was absolutely valid to my mind. You said that it should not be less than 12 per cent. But what the Finance Minister says is that it will be less than 12 per cent, because 85 per cent does carry 12 per cent and 15 per cent 'ess. Would you kindly request him that he changes the situation?

MR CHATRMAN: All right, in so far as it lies in the power of the Chair, it will say that there must be an equitable payment of interest for all people.

SHRI VISHWANATH PRATAP
SINGH: That 11 per cent is on the
State Government securities and if
hon. Members help on this, then, per-

haps something can be done. (Interruptions) On 85 per cent on the Central Government securities, it is 12 per cent.

SHRI NIRMAL CHATTERJEE: Even then they have to deduct at cost....

SHRI VISHWANATH PRATAP SINGH: I have answered it fully.

MR. CHAIRMAN: He will look into it. Please see that the employees provident fund interest is not less than the public provident fund.

SHRI VISHWANATH PRATAP SINGH: Sir, we need cooperation from the State Governments.

Indian national_s languishing in Pakistani jails

*SHRI LAL K. ADVANI:† SHRI KAILASH PATI MISHRA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) what is the number of Indian nationals at present languishing in Pakistani jai's and since when they are under detention;
- (b) how many of them are (i) defence personnel; (ii) valid passport holders; and (iii) others;
- (c) whether our embassy officials have been allowed to meet them; if so, with what results; and
- (d) what steps Government have taken in the recent past for the release of these people and what further steps Government propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI EDUARDO FALEIRO):
(a) to (d) A statement is laid on the table of the House.

Statement

- (a) About 942 Indian prisoners with detention periods varying from few weeks to 14 years are in Pakistan jail.
- (b) Out of the 942 prisoners, 43 are missing defence personnel. Many of the prisoners are without passports but 76 prisoners have intimated the details of their lost passports.
- (c) On 20-4-1986, Consular Access was provided in Multan Jail to Indian Embassy officials in Islamabad in respect of 124 Indian prisoners. Earlier 63 prisoners were repatriated to India on 20.2 1986.
- (d) In addition to the constant efforts at the diplomatic levels both at New Delhi and Islamabad, taken up at the matter has been meeting of the Foreign Secretaries (January, 1986) and the Meeting of the Sub-Commission-IV of the Indo-Pakistan Joint Commission (February, 1986). This was even discussed in a meeting between the Prime Minister and Gen. Zia in New Delhi in December, 1985. Constant efforts are made to repatriate all Indian prisoners Pakistan, The Pakistan Government has been requested to release all Indian detainees particularly those who have completed their sentences.

SHRI LAL K. ADVANI: Mr. Chairman, Sir, the hon, Ministe'r has informed the House that out of the 942 prisoners, 43 missing defence are personnel. My first question relates to the defence personnel. How many of these have been languishing in Pakis-1971 war? tan prisons since the Because if there are any, the Government owes an explanation to the country. How has this happened? Because that was a war in which we had more than 90,000 Pak soldiers

taken as prisoners. How is it that We released all of them without ensuring that every single person of our defence personnel is released? In the same context of defence personnel, I would like to ask another question. When you say that Consular Access was pro-Jail to Indian vided in Multan Embassy officials in Islamabad in respect of 124 Indian prisoners, does include this figure of 124 these 43 defence personnel?

SHRI EDUARDO FALEIRO: While we have been giving this figure of 43 defence personnel, it is true that these defence personnel were involved on our behalf on West Pakistan front at the time of 1971 conflict. The fact is that at that time we were not aware about the whereabouts of these people. But subsequently through the relations and other sources we found out that these personnel were in Pakistan.

Now, Sir, on the point whether Pakistan has failed to release these personnel, the fact is that the Pakistan Government is denying that these personnel are in jail. Now, from our information they are there. We have asked for Consular Access, but people who are produced before our Consular officers did not include these personnel. Now, we have asked Pakistan authorities to check their jail records and we have asked them to permit the relatives of these defence personnel to go there, particularly, to Multan jail where most of the Indian personnel and the detainees are to be found and other jails where they can also help to identify these personnel.

SHRI LAL K. ADVANI: Sir, you will appreciate that the answer which is given just now has completely changed the perspective of the earlier answer that has been given. I had presumed these 942 Indian prisoners with detention periods varying from a few weeks to 14 years were admittedly in Pakistan jail. This is a categorical statement on the basis of the information the Government of India has

had. Now, I am told that so far as 43 missing defence personnel are cerned, the Pakistan Government does they are admit that even This jail. is their in totally different picture. I know at least three occasions that on there have been talks on this issue at as high a level as the Prime Ministers' and Foreign Secretaries'. And so when this answer was given, I thought this is a position confirmed by both sides. Now I am told that so far as these 43 defence personnel are concerned Pakistan still denies it May be oven about these 942 persons, it still denies, I do not know. How many names have you got of these 942 prisoners? Have their families in India been informed that these are the persons held in prison, in detention by Pakistan? Also, at the end of the statement it is said:

"The Pakistan Government has been requested to release all Indian detainees particularly those who have completed their sentences."

So obviously even those who have completed their sentences have not been released. How is this? In the month of January, there was a meeting at the level of Foreign Secretaries. Mr. Romesh Bhandari, our Foreign Secretary, and Mr. Niaz Naik, Pakistan Foreign Secretary, met and they announced in ioint statement that by the 31st of March, all civil detainees who had completed their terms would be released. What has happened in pursuance of that declaration?

SHRI EDUARDO FALEIRO: Sir, as the hon. Member has pointed out, it is not only the defence personnel whose existence is not accepted the Pakistan Government Even in regard to the 942 people who, according to our information, are in Pakistan jails. thev do not accept total figure. The total number accepted by them is 344. They have given us 344 names on the 26th August. 1985 However, Sir, there are discrepencies that we can see.

SHRI LAL K. ADVANI: Any de-

fence personnel in these 344?

SHRI EDUARDO FALEIRO: No. This figure of 344 does not include defence personnel because Pakistan does not admit that a single defence personnel is there; 344 is the total figure. The figure of 942 is the figure that we have given on the basis of information from the relatives, on the basis of what our mission has able to find out and on the basis of reports in the Pakistan press itself. So there is this discrepancy. However, I may add here that without admitting the exact number, the Pakistani authorities have given us to understand that they are checking on their records. They have accepted our demand and our request that they should check on their own jail records in all their jails to find out one by one who Indian nationals detained are the there.

SHRI VISHWA BANDHU GUPTA: Mr. Chairman, Sir, the hon. Minister has said that these personnel were charged and the sentences of some of them are over. I would like to know from the hon. Minister what kind of charges were placed on these personnel, whether civilian or defence, whether he has additional information on that and whether any protests have been lodged with the Pakistan Government.

SHRI EDUARDO FALEIRO: Usually the charges are that the people who are detained in Pakistan jails were there either without passports or without valid visas.

SHRI DHARAM CHANDER PRA-SHANT: Sir, in the second week of this month, Pakistan voluntarily released some Indian prisoners and pushed them to our side at the Ganganagar border. One of them was Subash Chand from Jammu who was the work of this country when the Pakistanis arrested him and tried him on charges of spying. He was enced for seven years and even after seven years, he was kept in prison and he suffered imprisonment for 14 years. Now he has been arrested by Rajasthan police and detained in

Ganga-nagar, on what charge, I do not know. He has suffered mental and physical torture is Pakistan and now he is in the jail of Ganganagar. Will the hon. Minister intervene?

SHRI SHANKER SINH VAGHELA: The same thing happened on the Gujarat border. Some detainees were released on the border. We do not know what happened to them.

SHRI EDUARDO FALEIRO: This is a suggestion for action—whether we would intervene in the matter. I would definitely look into the specific case. I do not have the information now. But I will write to the hon. Member.

SHRI V. GOPALSAMY: Mr. Chairman, Sir, letters received by members of the families from the prisoners in Pakistan jails reveal that the conditions in Pakistan jails are very inhuman, What action has the Government taken in this regard to redress their grievances?

SHRI EDUARDO FALEIRO: I would not like them to experience at any time the conditions in Pakistan jails. We want them to be released. We have been working in this direction.

SHRI SURESH KALMADI: Sir, 942 persons are in Pakistant jails. That shows the total failure of our diplomacy. I would like to ask about the 43 missing defence personnel. Sir, time and again when you have been in the Chair, they promised us that they would look into the matter. Nothing has been done. I want to know if there is any Pakistan defence personnel in Indian jails and whether we are ready for exchange of the people...

SHRI EDUARDO FALEIRO: There are no Pakistani defence personnel in our jails and it is not correct that there has been any failure of our diplomacy. On the contrary, our diplomacy has proved to be very successful in getting the people released...

MR. CHAIRMAN: Question Hour over. After the Question Hour is over, even the Minister cannot continue.

The programme of computerisation has been so designed as to ensure that there is no retrenchment of staff, and bank employees have been given a firm commitment in this regard.
