## Influx of Tribals from Bangladesh into Tripura

768. SHRI J. P. GOYAL: SHRI CHITTA BASU; SHRI RAMKRISHNA MAZUMDER:

Wiil the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whethet it is a fact that the Bangladesh security forces bas launched a conncerted onslaught on the tribals of the Chittagong Hill Tracts forcing their influx into the country and that over 5000 tribals were forced to cross over into Tripura in June, 1986 atone, if so, the details thereof;
- (b) whether Government have taken up the matter with the Government of Bangladesh; and
- (c) il so, what is Bangladesh Gov-<ernments response thereto?</pre>

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI K. R. NARAYANAN): (a) Ye<sub>s</sub> Sir. More than 5,000 Chakma tribals had crossed from the Chittagong Hill Tracts of Bangladesh into Tripura during June 1986 as a result of armed conflict between Bagladesh security forces and Chakma gueriilas. As on. July 221, 1986 a total of 22, 892 Chakma refugees had entered Tripura from Bangladesh.

(b) and (c) The question of the early return of these refugees to their homeland had been discussed with the Government of Bangladesh and they have promised to take action to work out modalities jointly with the Indian side for the return of these refugees.

## Military aid to Pakistan

THE MINISTER OF STATE THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI EDUARDO FALE-IRO): (a) and (b) Pakistan has been acquiring sophisticated military hardware including tanks, guns, armoured personnel carriers, missiles, attack helicopters and F-16 aircraft from a number of countries including the U.S.A.

(c) Government continue to maintain a constant vigil over all developments having a bearing on the country's security.
