permitted to import polyester fabrics and zip fasteners of foreign origin free of duty under the DEEC Scheme ior manufacture of ready-made garments for export, undei* bond. Accordingly, they imported 1.13 lakh metres of polyester fabrics valued at Rs. 12.5 lakhs (CIF) and one lakh piece of zip fasteners valued at Rs. 1.03 lakhs (CIF) in March, 1986.

In order to fulfil the export obligations und;r the Scheme, the Unit filed four Shipping Bills for export of ready-made garments consigned to a party in Afghanistan. These consignments were duly examined and cleared for export out of the bonded warehouse. The goods were declared and certified as IOO per cent polyester garments (ladies night dresses/ nightwears) with 20 Cms. polyester zips.

On information, all the four consignments were intercepted and re-examined by customs authorities and they were found to contain ready-made garments made out of cotton fabrics of Indian origin mixed with ready made garments made out of polyester fabrics. Some of the zip fasteners fitted on the garments were of Indian origin. The goods contained in the four consignments valued at Rs 16.15 lakhs were seized under the provisions of the Customs Act, 1962.

Investigations conducted revealed that the Unit clandestinely removed and disposed off a part of the polyester fabrics and zip fasteners in the open market. In this connection, four persons including the officer of Customs, incharge of Bond were arres ted under the Customs Act. Polyester fabrics, cotton night dresses, polyeser ladies night dresses, and zip fasteners valued at Rs. 41.75 lakhs were also seized from the factory premises pf the firm.

The officer of Customs concerned has also been placed under suspension.

"African Plan" to augment exports to African countries

796. SHRI KRISHNA KUMAR BIR-LA: Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that Government formulated an "African Plan" sometime back to augment exports to the African countries; and

(b) if so what are the details thereof alongwith the follow-up strategy, if any, drawn up in this regard and the results achieved so far?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI BRAHM DUTT): (a) and (b) A Plan for coordinated effort to promote exports to Selected African Countries was prepared sometime ago which took into account the trade linkages with India, the potential and development programmes of these countries. It covered activities such as participation in exhibitions and fairs, interaction between trade bodie; etc. While such activities have been selectively carried out, the balance of payment crises in many of these countries, continued adverse weather conditions which have affected some economies and political uncertainties have stood in the way of implementing the Plan as such.
