(a) whether there is any proposal under Government's consideration for raising the age of marriage for girls

from 18 to 20 years and for boys from 21 to 25 years as also for offering other incentives keeping in view the need for family planning in the country;

(b) if so, what are the details thereof and by when a final decision is likely to be taken in the matter; and

(c) to what extent the target of family planning is likely to be achieved?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI S. KRISHNA KUMAR): (a) to (c) Although there is no such specific proposal raising the age of marriage particularly of women, is being perceived as an effective intervention towards our efforts for achieving population stabilisation.

(2. The Department of Women and Child Development in the Ministry of Human Resource Development and the Ministry of Home Affairs are responsible for implementation of the provisions of Child marriage Restraint Act.
