- 8. Direct payment from the treasury.
- 9. Common cadre for +2 and +3 teachers.
- 10. Abolition of discrimination between the teachers of State and central universities and colleges affiliated to these with respect to all perquisites.
- 11. Age of superannuation not below 60 years.

A pay revision committee appointed by the UGC for the revision of salary scales of teachers in universities and colleges has considered those of the demands which concern pay scales and conditions of service of teachers. The Committee has submitted its report in June 1986. Government will examine the report and take a view on the recommendations contained in the report.

NARASIMHA RAO): (a) to (c) 395 Hostels have been sanctioned different parts of the country under the Central Scheme of Assistance for Construction/Expansion of Hostel Building for Working Women with Day-Care Centre for Children.

Under the Scheme, assistance is provided to the extent of 75 per cent of the cost of construction of the hostel building or purchase of building excluding the cost of land, furniture and fixtures, to voluntary organisations/public Trusts/local bodies or cooperative institutions working in the field of social welfare/women's welfare/women's education on receipt of applications through the State Government/Union Territory Administration concerned.

45 Working Women's Hostels have already been sanctioned in Madhya Pradesh. The Government of India will consider further proposals for Working Women's Hostels in Madhya Pradesh on receipt of applications from voluntary organisations through the State Government.
