# Manufacture of Disposable Syringes by Hindustan Latex Limited

- 105. SHRI PARVATHANENI UP-ENDRA; Will the Minister o\* HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether it is a fact that a proposal of the Hindustan Latex Limited, a public sector undertaking to manufacture disposable syringes has been held up at the official level;
- (b) if so, what are the reasons therefor;
- (c) whether it is also a fact that 30 per cent of the immunity care depends on disposable syringes most of which ar now imported; and
- (d) by when the proposal for the manufacture of disposable syringes by the Hindustan Latex Limited is likely to be cleared?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI S. KRISHNA KUMAR): (a) and (b) A pre-feasibility report indicating the possibility of setting up a Plant to manufacture disposable syringes has been received from the Hindustan Latex Limited. After examining the report, the Hindustan Latex Limited has been asked to prepare a feasibility report on the proposal.

- (c) Effective Immunisation does not depend upon the type of syringes used but on the quality of their sterilisation. A<sub>s</sub> per the pre-feasibility report the current demand for disposable syringes in the country is estimated at 30 per cent of the total requirement and, of this demand about 15 per cent is being imported.
- (d) A decision on the Hindustan Latex Limited manufacturing di^no-sable wil<sup>1</sup> be taken after an in-denth examination and accepting of the feasibility report.

#### Vayudoot service from Vijayawada to Guntur

THE MINISTER OF STATE IN THE DEPARTMENT OF CTVIL AVIATION (SHRI JAGDISH TYTLER): (a) No representation from the people of Guntur District for the introduction of a Vayudoot service from Vijayawada to Guntur has been received by the Government in the recent past.

## Request for Connecting Guntur with Superfast Delhi-Madras Trains

908. SHRI R. SAMBASIVA RAO: Will the Minister of TRANSPORT be pleased to state:

- (a) whether Government have received an<sub>v</sub> Memorandum/representation in the recent past from the people of Guntur District in Andhra Pradesh to connect Guntur with Delhi-Madras and Howrah-Madras by running super-fast expres<sub>s</sub> trains via that city;
- (b) if so, what are the details thereof; and
- *Xc)* what action Government have taken thereon?

THE MINTSTER OF STATE IN THB DEPARTMENT OF RAIL WAYS (SHRI MADHAVRAO SOINDIA): (a) and (b) Yes, Sir.

There have been representations to route long distance superfast trains via Guntur.

(c) Diversion of the trains will increase the journey time by at least "\* 2 hours as it involves change in traction from Electric to Diesel/ Steam, reversal of engine apart from longer distance and higher fares which will inconvenience the long distance passengers.

## Standing Committee to promote Family Welfare

- (a) whether it  $i_s$  a fact that an eleven Members Standing Committee on voluntary action to promote community participation in family welfare programmes has recently been constituted; and
  - (b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (-SHRI S. KRISHNA KUMAR): (a) and (b) Yes, Sir. A Standing Committee for Support Voluntary Organisations engaged in activities connected with family welfare has been constituted on 17th June, 1985, under the Chairmanship of the Chairman, Central Social Welfare Board, New Delhi and consisting of four officials (ex-officers) from the Government of India and, seven nonofficial members, who are active in the field of voluntary action. The term of office of non-official members will be 3 years, with 1/3rd of the members relinquishing office every year. The committee is to guide the voluntary organisations at the grass-root level in the rural areas and urban slums in identifying and preparing suitable projects and consider applications received from them for set\*ing up family welfare projects relating t<sub>0</sub> MCH, Family
