THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI AJIT PANJA) : (a) Yes, Sir. In March, 1986,

(b) A list giving the names and designations of the officers is given in the attached statement.

The raids were conducted by the C.B.I. and, on their advice, the Food Corporation of India have placed Shri S. N. Nigam, B. R. Bhanot and T. L. Bassi under suspension.

During the searches, movable and immovable property valued at Rs. 87.72 lakhs, was discovered. In addition, a large number of incriminating documents were recovered. All the cases registered in this regard are under investigation by the C.B.I.
