been taken. These include surprise checks in corruption-prone areas by special squads and senior officers of the Corporation, occasionally also with the help of the CBI, streamlining of rules, regulations and procedures, review of performance of officers to weed out those of doubtful integrity and delegation of greater powers to disciplinary authorities to enable taking of speedy action against delinquent officials.

Making compulsory ISI marking for goods to be purchased by the Government

991. SHRI D. B. CHANDRA GOW-DA: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether Government have decided to make ISI certification mark compulsory for goods to be purchased by the Government;
- (b) whether there is a proposal to put ISI certification marks compulsory on some of the goods; and
- (c) if so, the details thereof and what steps Government propose to take to ensure that the items would be of better quality after certification?

THE MINISTER OF STATE IN OF' MINISTRY PLANNING AND MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI AJIT PANJA): (a) No. Sir. However, it has been decided that Diectorate General Supplies & Disposals/Department of Supply will contract only for ISI marked goods wherever such goods are offerea; in case ISI-marked goods are not available, ISI specifications have to be strictly adhered to.

- (b) while, as on date 108 items have already been brought under compulsory Certification Marks Scheme of ISI, there are proposals to extend the compulsory Scheme to a few more items.
- (c) Some of the additional items proposed to be brought under com-

pulsory Certification Marks Scheme of ISI are as follows:-

- (1) Synthetic Detergents;
- (2) GLS Lamps;
- (3) Plywood;
- (4) Surgical Implants;
- (5) Clinical Thermometers:
- (6) Hydraulic Brake Fluids:
- (7) Domestic Electrical Appliances;
- (8) Infant Milk Powder.

When articles are brought under compulsory ISI Certification Marks Scheme, the manufacturers are required to ensure that such articles manufactured by them conform to the standards/specifications prescribed by the ISI. It ensures better quality of the products after certification.
