#### Return of Indian Scientists and Technologists from US

957. DR. MOHD. HASHIM KIDWAI:  
Will the PRIME MINISTER be pleased to refer to answer to Unstarred Question 323 given in the Rajya Sabha on the 25th July, 1985 and state:

(a) what is the number of Indian scientists and technologists who had returned to India till June, 1986 from the US in response of the call of the Prime Minister given last year; and

(b) what are the details of their placement and employment?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI SHIVRAJ PATIL):  
(a) and (b) Indian scientists and technologists returning from abroad are generally engaged in the following activities:

1. Self-employment by way of setting up industrial units.
2. Private sector.
3. Public sector.
4. Autonomous S&T organisations/institutions.
5. Government Departments.

It is therefore, very difficult to ascertain the exact number of India scientists and technologists who return to the country from abroad. However, a scheme called the "Scientists Pool" has been in operation since 1959 for temporary placement of well qualified Indian scientists and technologists, primarily those returning from abroad. During the period 1st June, 1985 to 30th June 1986, 56 persons were selected to the Pool from USA. Out of these, 7 have obtained regular employment in India and left the Pool. Of the rest, 36 persons are working in the Universities and Institutions of National importance, 5
