(1) Bodhghat Hydro-electrical Project in Bastar district.

- (2) Bhond Tank Project in Bastar district.
- (3) Narmada Sagar Multipurpose project.
- (4) Indore-Sarni 400 KV Transmission line.
- (5) Matimotinalla Tank Project in Rajnandgaon district.
- (6) Laying of gas pipe-line by Gas Authority of India Limited in Guna, Jhabua and Shivpur district.
- (b) and (c) Approval of the Central Government for diversion of forest lands for the Indore-Sarni 400 KV Transmission Line, Bhond Tank Project, Matimotinalla Tank project and Laying of gas pipe-line by Gas Authority of India Limited, has since been accorded.
