The recent killing and loot on March 11 is an upshot of a diabolical plan hatched by the TNV with patronage from Bangladesh. At least 10 battalions of the BSF are required to guard the State's 900 - kilometres international border with Bangladesh. Tripura has only five battalions now. The State Government has been urging upon the Centre to rush additional para-military Forces and also to seal the international border between Bangladesh and the State of Tripura.

Sir, in conclusion, I would urge upon the Prime Minister and the Government that while he meets Mr. Laldenga during this week or the next week, he should refer this matter, to Mr. Laldenga and ask him to sever all connections, if there are any, with the TNV. I would also request the Government to take up this matter with the Government of Bangladesh so that the TNV cannot enjoy the patronage of that Government as it has been enjoying during the last few years.

Also, Sir, there is an apprehension as expressed by the State Finance Minister that Andhra Prad' sh would not increase its allocation project as per the ratio. Without sharing the cost, the S< ould not make any furt! u r headway within time span purely with the contribution from Tamil Nadu. I am urging the Government, through you, Sir, and particularly the Prime Minister that | rne must be given ealry clearance. Also, I request the Government to gh >n to the State Government of And!.ra Pradesh to act according to the Accord reached between the States of Tamil Nadu and Andhra Pradesh which will facilitate the Madras people to have cr early.
