(ग) और (घ) वर्ष 1985-86 की सफल सीजन के दौरान 15 आरस से अधिक व्यक्तिगत जॉन के रकवे में 20 प्रतिशत की कटौती की गई जिसके परिणामस्वरूप मध्य प्रदेश में 35,713 काश्तकारों के संबंध में 651.69 हैक्टयर्स की कुल कमी हुई है।

(ङ) वर्ष 1980-81 की तालिम कार्यवाही के दौरान मध्य प्रदेश में मारवा में "मैनेज कम" से सम्बद्ध 63 काश्तकारों के लाइसेंस केन्द्रीय जांच ब्यूरो के निष्कर्ष के आधार पर, वर्ष 1984-85 की फसल के दौरान रद्द कर दिए गए थे। इन काश्तकारों को वर्ष 1985-86 के दौरान भी लाइसेंस जारी नहीं किए गए हैं।

Regional Rural Banks

928. SHRI NIRMAL CHATTERJEE;

SHRI SHANTIMOY GHOSH:

Will the Minister of FINANCE be pleased to state;

(a) whether any problem[®] concerning the Regional Rural Banks and their employees have been brought to Government's notice;

(b) if so, the details thereof; and

(c) the steps proposed to be taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) and (b) The main problems of Regional Rural Bank employees, brought to the notice of Government relate to parity of pay scales and other service conditions with commercial banks, inter-bank request transfers, setting up of a negotiating forum for discussing employees grievances, etc. The main problems being faced by Regional Rural Banks relate to industrial relations, attainment of viability, recruitment and manpower planning

(c) There is a Steering Committee headed by Chairman of NABARD to oversee the functioning of the Regional Rural Banks. A number of steps have been taken by Government to solve the problems of Regional Rural Banks and their employees. Separate State-level Forum, under the convensorship of NABARD have "been set up to discuss exclusively the problems and grievances of Regional Rural Bank staff. The recruitment of staff in Regional Rural Banks has been entrusted to Banking Service Recruitment Boards in order to streamline the process. With a view to suggesting suitable changes in the structure, planning and operational strategies of Regional Rural Banks, Government have set up a Working Group under the Chairmanship of Additional Secretary (Banking).
