### Internal Railway in Kashmir Valley

(b) if so, what are the details thereof and by when work for its construction is likely to be started?

THE MINISTER OF STATE IN THE DEPARTMENT OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Yes, Sir.

traffic-cum-engineering (b) The survey for an electrified railway line connecting Gazi Gund and Baramulla via Srinagar was carried out in the year 1973 at the cost and request of the State Government of Jammu and Kashmir. The length of the line surveyed was 122.35 Kms. At 1973 price level the c°st was estimated to be Rs. 81 crore if constructed as MG, and Rs. 89 crores if constructed as BG. The project was not found to be financially viable, the return being negative. At current prices, the cost of the Project would be several times more. There is no proposal at present for taking up this work due to constraint of resources.

Circulation of fake drugs

# 1027. SHRI KALPNATH RAI: SHRIMATI SUDHA VIJAY

Will the Minister of HEALTH AND FAMILY WELFARE be pleased: to state;

JOSHI;

(a) whether Government are aware of the reports about the circulation of several fake drugs; and

(b) if so, what steps have been taken by Government in this regard?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WEL-FARE (SHRI S. KRISHNA KUMAR): (a) Under the provisions of the Drugs and Cosmetics Act and Rules made thereunder, control over the manufacture and sale of drugs is exercised by the State Drug Control Authorities. Action to detect the production and distribution of spurious (fake) and adulterated drugs has therefore mainly to be taken by them. If a case of manufacture or sale of spurious (fake) is detected the State Drug Authorities take action to seize the spurious drugs and launch prosecution against the involved persons.

(b) To tack the problem of substandard drugs, the Governments of up a Task Force which recommended that:

(1) every drug manufacturing unit should have minimum testing facilities. (2) strict control over licensing of drug formulations.

(3) strengthening of the Inspectorate staff in the State.

(4) establishment of a separate intelligence machinery to tackle the problem of manufacture and sale of spurious drugs.

(5) constitution of special courts to deal with the offences under Drugs and Cosmetics Act.

Its recommendations were commuto the State Government and nicated the State Governments have been requested repeatedly to give effect to the recommendations. A proforma has been prescribed for monthly submission of reports by the State Drugs Controllers and the State Government have been requested to send monthly reports on drawal of samples and analysis of them. These reports are being consolidated and commented upon. Also a list of equipments necessary for drug testing laboratories has been communicated to the State Units and the State Governments have been requested to equip their laboratories On 22nd February, 1986 accordingly. a meeting of the State Health Minister was held exclusively to discuss matters relating to implementation of Drugs and Cosmetics Act and the P. F. A. Act. At the meeting the Health and Family Welfare Minister urged the State Health Ministers to strengthen the drug control machinery with the object of putting down production distribution and sale of substandard and spurious drugs.

(b) According to information furnished by the University Grants Commision, it has been decided to declare the Andhra Pradesh Open University, Hyderabad, fit to receive Central assistance in term<sub>5</sub> of the rules framed  $u_n$ der Section 12 B of UGC Act subject to the amendment of the Act of the University and on receipt of an assurance from the University that it would use of the balance amount of Rs. 87.84 lakhs on studios, library and academic buildings, so that the total permanent assets of the University are worth Rs. 2 crores.
