Compensation to the next of kin of the victims of Kanishka disaster

1078. SHRI L. GANESAN: Will the Minister of TRANSPORT be pleased to refer to the reply to Starred Question 236 given in the Rajya Sabha on the 4th December, 1985 and state:

(a) whether compensation has been paid to the next of kin of all the victims of Kanishka disaster;

(b) if not, what is the break-up of the cases in which the compensation has been paid and which are pending for payment till date, along with details; and

(c) what steps are being taken by Government to pay compensation in the remaining cases, if any?

THE MINISTER OF STATE IN THE DEPARTMENT OF CIVIL AVIATION (SHRI JAGDISH TYTLER): (a) and (b) *£j*, on 28th February, 1986, an amount of Rs. 2.24 crores has been paid in India as final settlement in respect of 52 passengers. In addition, Rs. 76.26 lakhs has been paid in settlement of compensation cases of 19 crew members.

Payment of compensation in respect of 255 passengers and 3 crew members is pending. Out of these pending cases, claims of 50 passengers were received in India and 166 in Canada. Formal claim applications in respect of 39 passengers are still awaited.

(c) Air India had inserted advertisement in various English and vernacular news papers inviting claims from eligible members of the families of victims. Leaving aside cases which are pending in Courts of Law. Air India are contacting claimants for expeditious settlement of the claims.

(a) how many new drugs have been cleared for marketing in the country during 1984 and upto 28th February, 1986 alongwith the name of each drug;

(b) how many drugs were cleared on the basis of clinical trials alongwith the name of each drug;

(c) how many applications are still pending for clearance along with name of each drug; and

(d) what is the position of each drug and by when these are likely to be allowed for marketing?

THE DEPUTY MINISTER IN-THE DEPARTMENT OF FAMILY WELFARE (SHRI S. KRISHNA KUMAR):
(a) and (b) 41 drugs have been

cleared for marketing in the country during 1984 and upto 28th February, 1986 as per details given in the statement attached (see *below*). Out of these, 34 drugs have been approved on the basis of the clinical trials carried out in the country. The remaining drugs have not undergone clinical trials in the country. They are either anti-cancer drugs or life saving drugs which have been approved for marketing in the country on the basis of advice given by the experts consulted in the respective field.

(c) and (d) It is not feasible to furnish information regarding the names of drugs "that are awaiting clearance and likely date of their clearance for marketing in the country
