Defection by an Indian Diplomat in Norway

- (c) and (d) Government took up the matter of Sh. Harinder Singh's desertion with the Norwegian authorities both in Oslo and in Delhi. In the absence of any Extradition Treaty between India and Norway the question of extradition of Sh. Harinder Singh was not formally pursued.

National Computer Policy

1243. SHRI SURESH KALMADI: SHRI DHARAM CHANDER PRASHANT:

Will the PRIME MINISTER be pleased to state:

- (a) whether Government propose to introduce a National Computer Policy for the country;
- (b) how many jobs are likely to be created during the Seventh Plan period as a result thereof; and
- (c) whether Government propose to ban the use of computers for office application?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI SHIVRAJ PATIL): (a) The Government has already formulated a National Computer Policy which was notified in the Gazette of India dated 31st August, 1985.

- (b) According to the Report of the Panel on omputer Manpower Development, set up by the Department of Electronics, 60,000 jobs will be created during the Seventh Five Year Plan, directly due to computerisation. Indirectly, the higher productivity and better decision-making facility by computerisation will increase national wealth which fed back into the newer economic activity will in turn create employment.
- (c) No, Sir, because there are numerous office applications of com-

puters, which are beneficial for efficiency, productivity and quality of service.

Cost escalation in public sector projects

1244. SHRI SATYA PEAKASH MALAVIYA

SHRI VIRENDRA VERMA:

Will the Minister of PROGEAMME IMPLEMENTATION be pleased to state:

- (a) whether there has been alarming cost escalation in respect of a large number of public sector projects in the key sectors like Power, Coal, Steel, Atomic Energy etc. and that the completion of major and minor irrigation projects has been taking nearly 20 years for completion; and
- (b) if so, what are the details thereof stating the factors identified for
 the inordinate delay in the completion
 of public sector projects, the extent
 of their cost escalation as against the
 original estimated cost and the prospects of their completion in the
 Seventh Five Year Plan?

THE MINISTER OF PROGRAMME IMPLEMENTATION (SHRI A.B.A. GHANI KHAN CHOUDHARY): (a) Yes, Sir. There has been escalation in the cost of a number of Central/Public sector projects in Power, Coal, Steel and Atomic Energy sectors. As regards irrigation projects, it may be pointed out that irrigation is a State subject and these projects are planned funded and implemented by the State Governments. It is correct that completion of some major irrigation projects has taken 20 years or more.

(b) Details of the Central projects, costing over Rs. 100 crores each being monitored by the Ministry of Programme Implementation and where cost escalation has taken place, are given in the enclosed Statement (See below). AllProjects except the ones at Sl. No. 21, 26, 29, 30 and 35 (5 in number), are, as of now anticipated to be completed within the 7th Five Year Plan.
