(c) The steps being taken by the Government include tightening of rules and regulations related to issue of driving licences, strict medical tests, certification of vehicle tests, enforcement of maximum safe axle weights permissible for transport vehicles and improvement of geometrix inter-section improvements. Besides launching National Highway patrol scheme on selected sectors of National Highways, establishment of Driver Training School in Delhi for imparting comprehensive training to improve driver skill and driver habits, the State Governments and Union Territories have also been advised to formulate and implement the schemes of Highway Patrol in respective areas and to set up driver training schools.
