- (c) The performance is judged by comparing achievement against targets wherever set. Based on performance productivity index is determined in respect of each year's production and the efficiency $i_{\rm s}$ judged relatively by comparison of the index with that of past years.
- (d) The budget of Ordnance Fac tories forms a part of Army Budget. So the question of selling products of Ordnance Factories to Army does not arise. Issues to Navy and Air Force are costed and book adjustments are made between the accounts of Army on the one hand and of the Navy and Air Force on the other.

concerns regarding Pakistan's assistance to extremists and terrorists have been conveyed to the Government of Pakistan ton different occasions and at various levels. Pakistan has denied giving such assistance but our information is to the contrary.

fd) Government continues to maintain a constant vigil over ail developments having a bearing on the country's integrity and sovereignty.
