The following steps have been taken in SAIL steel plants to improve the quality of steel:—

- (1) Strict quality control measures are taken at every stage of processing right from intake of raw materials to production of final rolled product.
- (2) Automation and sophisticated control of process parameters are being planned and getting introduced at blast furnace, steel melting shop, soaking pits and reheating furnaces and at rolling stage.
- (3) Sophisticated technology of vacuum degassing and ladle metal lurgy are being planned for introduction in the near future.

To contain price increases, the following measures, some of which are of continuing nature, have been taken in SAIL steel plants:

- (i) Regular monitoring of cost of production both at the corporate and plant level.
- (ii) Emphasis on optimal utilisation of available sources within the organisation.
 - (iii) Costs like overtime, demurrage are being controlled through strict monetary limits.
 - (iv) Energy conservation.
- (c) SAIL are in the process of completing their schemes to expand the capacities at Bhilai and Bokaro to 4 MT per annum. Schemes have also been formulated and funds provided in the 7th Plan to modernise the steel plants at Durgapur and Rourkela so that they may be able to attain their rated capacities of 1.6 MT and 1.8 MT per annum respectively.

District Centre near Wazirpur Depot Delhi

- (a) the purpose for which land on ting road near Wazirpur Depot in Delhi and opposite district centre is earmarked;
- (b) the details of the project proposed to be constructed on this land; and
- (c) by when the construction on the project is likely to start and complete?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) The land on ring road near Wazirpur Depot has been earmarked for service industries/transport terminal according to Delhi Master Plan/Zonal Development Plan.

- (b) About 6 hects, of land has been allotted by DDA for the construction of DTC Depots and a Printing Press Complex has been planned in an area of 3.5 hects. 16 plots have been carved out for Printing of Newspapers.
- (c) DTC Depots have already been constructed and are functioning, Development work for the Printing Press Complex has been started recently.

- (a) The anticipated irrigation potential created up to the end of Sixth Plan is 67.9 Million hectares.
- (b) A target of 12.9 million hectares of additional irrigation potential has been fixed for the Seventh Plan.
- (c) The approved Government outlay for irrigation sector during the Seventh Plan is Rs. 14360.55 crores alongwith an anticipated institutional investment of about Rs. 3500 crores.
