they are getting high salaries as white elephants of the ITDC. What are you going to do with this particular' problem?

H. K. L. BHAGAT: So far as Tamil Nadu is concerned, the lodges, as I have submitted, have not been handed over yet. The whole matter is under discussion. Our policy is that all the officers who are attached to the travellers lodges which have been handed over to some States, if these have been handed over to the Tamil Nadu Government, they are taken back. They can either go back to the ITDC with full protection of their salaries, or if some of them want to get retrenchment benefits, they can taken them. The idea is that nobody should remain unemployed.

SHRI R. MOHANARANGAM: Sir, it is a well-known fact that Tamil Nadu Tourism Corporation is functioning properly. Its functioning was appreciated by our hon. Minister when he came to Madras. I have visited the Kanchipuram ITDC where I found not even a single room was occupied because it is one and a half Or two kilometers away from the Kanchipuram City. When I enquired about that they told me that it was going to be handed over to Madras State Department. I was told this two years The hon. Minister in his reply has earlier. said that there are certain terms and conditions for transferring the lodge to the Department. I would therefore, like to know what exactly are the terms and conditions. Secondly even though it is not somewhat pertinent to this question, the Minister has stated that there is a joint venture with the Stae Government for starting the Yatri Niwas, I would like to know what exactly is the stage of starting the ioint venture at the Corporation building namely the RiPPOn building, otherwise know as Kannappar Thidal.

SHRI H. K. L. BHAGAT: I must admit I have a feeling that the Tamil Nadu Tourism Department have been doing a good job. I did appreciate them and I appreciate them again here. Similarly the Central Government Ministry of Tourism has also been doing a good job. So far as Tamil Nadu is concerned it is rjanctioning a number of schemes.

Now, So far as the terms and conditions of transfer of these forest • lodges are concerned one is that we wish to transfer them on book value. Secondly, so far as the "staff is concerned I have already said if the State Corporation does not want them, they can remain in the ITDC.^-They will be given alternate jobs and will be given retrenchment benefits. These are basically the 2 conditions. The Centnal overnment is keeen that the State Government should take it over.

MR. CHAIRMAN: We go over to the next question.

SHRI R. MOHANARANGAM: Sir, he has not replied about the joint venture.'?. You have allowed this question.

tSHRI JAGDISH JANI; What are the , reasons that led to the decline in the procurement of iron-ore from different mines for steel plants in 1985-86 when compared to the preceding year 1964-85? I would like to know whether his Ministry will request the Steel Authority of India Ltd. to increase the procurement of iron-ore *or steel plants.

SHRI P. SHIV SHANKER: The reasons for the decline of the export from Orissa are that the total export from the Paradeep port have been falling because its port capacity of 53,000 DWT can accommodate smaller size vessels as against the Vizag and Madras Ports which were expanded earlier to 80 to one lakh tonne and are being further expanded. Smaller size vessels mean more shipping freight per metric tonne. Hence the landed cost of ore in Japan and Korea is more.

With the change in the world shipping fleet of other major importing countries, large sized vessels came. As such the use of other Indian ports increased and that of the Paradeep port declined and most of the traffic which was earlier going to Paradeep shifted to Madras.

' Vairious stej^ have been taken to promote the export from the Orissa region. I would not like to go into them, because the hon. Member has only asked the reasons for the decline. Steps are being taken to see that the Paradeep Port is improved in order to strengthen its DWT capacity.

JAGADISH JANI; Sir, I would like to know whether the hon. Minister has received any Memo-tatvdum from the Owners Association for revising the Mine procurement prices of iron ore for the Steel

plants and also for export purposes. If so, what are the steps taken in this regard?

SHRI P. SHIV SHANKER: Sir, I have not received any such memorandum.

SHRI AKSHAY PANDA: The Minister has stated in bis reply that MMTC proposes to procure 20 lakh tonneg of iron ore for export during 1986-87. But I would lilce to know what steps the Government would take to further export of iron ore in the increase Seventh Plan? If so, which countries have been India and contacted to import iron ore from particularly froCT(Orissa mines? The Minister has stated just now and last week also he has isaid that because of the drowning of a dredger in the Paradeep port our export has been declining. In view of this, what sheps the Government is going to take to improve the facilities as the Paradip - -port,

SHRI P. SHIV SHANKER; Sir. the Government proposes to increase the export in the Seventh Plan from the Orissa region. The main countries where the iron ore is exported are: Japan, South Korea, Taiwan and West Europe.

On the question of the Paradeep port, I have already made this submission just now and last week also that recently a second dredger was sunk in the waters as a result of which the capacity of the loading has gone down. The bigger ships which were previously in a position to come up are not in a position to come up. Even the capacity loading has gone down. The Surface Department is taking necessary stepg to see that the dredger is removed.
