Enclosing of leaflet containing the indication and contra-indication of the Medicines

2377. DR. JOSEPH LEON D'SOUZA:
Will the Minister of HEALTH AND
FAMILY WELFARE be pleased to
state:

- (a) whether it is a fact that according to Drugs and Cosmetics Rules, it is mandatory to enclose a leaflet given the indications and the contra-indications in the pack containing the medicines;
- (b) if so, whether it is also a fact that there are a number of drug manufacturing companies which do not provide such leaflets; and
- (c) if so, what steps Government have taken in the matter?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI S. KRISHNA KUMAR):
(a) The Drugs and Cosmetics Rules do not contain a specific provision requiring manufacture to include a package insert in the Packages on medicines marketed by them containing information on indications and adverce effects.

(b) and (c) Do not arise.

- (e) whether Government are aware about the dangerous effects of the indiscriminate use of aspirin;
- (f) if so, what are the details and the remedial steps taken by Government;
- (g) whether Government have received any reports on the adverse effects on indiscriminate use of aspirin in this direction; and
- (h) if so, the details and action taken thereon?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI S. KRISHNA KUMAR):
(a) Yes, Sir.

- (b) to (d) The Drugs Technical Advisory Board, a Statutory Body, considered that Aspirin in normal conditions can be used by the people and the prescriptions for its retail sale is not necessary. It is not mandatory to give a cautionary note alongwith the containers of the drug Asprin.
- (e) and (g) No dangerous effects reported with the use of Aspirin have come to our notice.
 - (f) and (h) Do not arise.
