was no cause for banning anabolic steroids which constitute $_{a}$ useful of drugs. On the advice of the ICMR the single ingredient preparations of anabolic steroids are allowed for continued marketing subject to specific indications and guidelines $^{p}:>r$ use. Indications and warning are being included in the packag insert. However, based on the recommendations made by the medical experts, the manufacture and sale of combinations of anabolic steroids with other drugs has been prohibited by the Government.

As per the information available, preparations containing AnaDolic Steroids are being marketed in many developed and developing countries.

Manufacture of anti-leprosy vaccine in India

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state*

(a) whether it is a fact that anti-leprosy vaccine has been manufactured in India;

(b) if so, what are the details in this regard;

Ce) whether this vaccine has been tested on human beings; and

(d) if so, the result thereof and by when it is likely to be introduced in the hospitals?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRIS. KRISHNA KUMAR): (a) to (d) An active Research work is in progress to develop anti-leprosy vaccines by two Indian Scientists-one from the Cancer Research Institute, Bombay and the other from the All India Institute of Medical Sciences, New Delhi. A third vaccine from killer M. Laprae is being considered for trial in India. The vaccine developed so far are under clinical trials for proving their efficacy and suitability for mass use. As leprosy has a long incubation period, it takes long to evaluate the efficacy of these vaccines. The question of introduction of these vaccines in Hospitals at this stage does not arise.
