- (c) The proposals for withdrawal of irrational drug combinations are reviewed by the Drugs Technical Advisory Board (DTAB) which is a statutory body under the Drugs and Cosmetics Act to advise the Government on all technical matters. Necessary action to ban the manufacture and sale of irrational drug formulations is taken by the Government based on the recommendations made by the D.T.A.B.
