(ii) to establish parameters for such systems to suit Indian cities and conditions;

(iii) to establish capabilities and costs of various systems manufactured internationally and the expertise and general commercial conditions with which they are available looking at the trade-offs betwesn various alternatives;

(iv) to consider any other issue relevent to the subject.

(c) (i) The Study Group has been to asked to submit its report to the Ministry within 6 months time. Decisions on the recommendations of the Study Group will be taken after its report become^ available to Government.

(ti) The Seventh Five Year Plan Provides for only completion of ongoing metropolitan transport scheme in Calcutta, Bombay and Madras subject to availability of requisite funds.

'Ribbon' (side road) Development

2420. SHRI KAPIL VERMA; Will h^{A} Minister of TRANSPORT be pleased to state whether Government has set up a task force to examine a suitable legisla tion to implement 'Ribbon' (side ioad) development and whether State Govern ments have also been asked to sponsor such resolutions to give effect to it for road development, if ao, what is the progress?

THE MINISTER OF STATE IN THE DEPARTMENT OF SURFACE TRANS-PORT (SHRI RAJESH PILOT): Yes. Sir. Only 10 States have so far adopted Resolution under Article 252 (1) of the Constitution authorising the Parliament to enact Central Legislation on prevention of ribbon development along National Highways. Similar Resolution from the remaining States are still awaited.

Handing capacity of Paradip Port

2421. SHRI SHEO KUMAR MISHRA: SHRI KAPIL VERMA;

Will the Minister of TRANSPORT bo pleased to state:

(a) what is the present capacity of handling of large size vessels by the Paradip Port;

(b) whether it is a fact that the capacity bias been reduced because of the sinking of a dredger last year; and

(c) whether there is any proposal for joint efforts by India and South Korea to imptrove functioning of the Port?

THE MINISTER OF STATE IN THE DEPARTMENT OF SURFACE TRANS-PORT (SHRI RAJESH PILOT): (a) Paradip Port presently takes vessels of loaded draft of 11.9 M with an LOA of 230 M.

(b) Presently the restriction is only on the LOA of th_e vessels and not in the draft.

(c) A proposal was received from M/s. Hyundai Corporation of South Korea through MMTC for the development of Paradip Port i_n order to enable it to receive iron ore carriers upto 1,70,000 DWT loaded to 17 M draft.
