

(b) The project is being implemented in the States of Gujarat, Madhya Pradesh, Andhra Pradesh, Tamil Nadu, Orissa, Maharashtra and Karnataka. In these States, oilseed grower's cooperative federations have been organised at State level and oilseed grower's cooperative societies have been organised at village level. These societies have been entrusted with the work of production enhancements and procurement of oilseeds. At the State level, arrangements have been made by the federations for marketing and processing of oilseeds.
