

**WRITTEN ANSWERS TO QUESTIONS****Decline in exports**

\*24. SHRI RAJNI RANJAN SAHU: Will the Minister of COMMERCE be pleased to state:

(a) whether India's exports have shown a perceptible decline during the last one year; if so, what are the details thereof and the reasons therefor; and

(b) what steps have been taken to improve the balance of trade position?

THE MINISTER OF COMMERCE AND FOOD AND CIVIL SUPPLIES (SHRI P. SHIV SHANKER): (a) No Sir. According to preliminary figures, exports during April-September 1985-86 were Rs. 5017.63 crores compared to Rs. 5054.26 crores in the corresponding period in the previous year thus being only 0.7 per cent lower. However, excluding crude oil, the exports were Rs. 4882.48 crores compared to Rs. 4537.93 crores in the corresponding period in the previous year, thus showing an increase of about 7.6 per cent.

(b) A series of policy measures have been taken in order to increase the supply of commodities and manufactured goods for exports, making our exports competitive and for their marketing and promotion. Simultaneously, efforts are also being made to step up our indigenous production of importables during the Seventh Five Year Plan period, particularly of bulk commodities.

**Study of Abid Hussain Committee Report on trade policies**

\*27. SHRI K. MOHANAN: Will the Minister of COMMERCE be pleased to state:

(a) whether the inter-Ministerial Committee has considered the Abid Hussain Committee report on trade policies and submitted its recommendations; and

(b) if so, what are the details of the recommendations made in this regard and Government's decision thereon?

THE MINISTER OF COMMERCE AND FOOD AND CIVIL SUPPLIES (SHRI P. SHIV SHANKER): (a) and (b) The Report of the Committee on Trade Policies, headed by Siri Abid Hussain, has been considered by the Government. Copies of the Report were made available on 28.8.1985 to the Parliament Library.

The Report contains many broad conceptual recommendations, general recommendations which need elaboration before being implemented and operational recommendations. These have mostly been accepted. Several recommendations have been implemented or are in the process of being implemented. Some recommendations are being further examined.
