Report of Indo-US Task Force on the Indian Ocean

- 412. SHRI PARVATHANENI UPEN-DRA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether Government's attention has been drawn to a news item which appeared in the Times of India of 2nd December, 1985 under the caption "Indian Ocean rivalry may lead to war"; and
- (b) what action has been taken by Government on the report of the Indo-US Task Force regarding continuing instability in the Indian Ocean region?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. R. NARAYANAN): (a) Yes, Sir.

(b) The Indo-American Task Force on the Indian Ocean was a Non-Governmental group co-sponsored by the Institute of Defence Studies and Analyses from India and the Carnegie Endowment for International Peace from the United States. The report of the group is a valuable compilation bringing out the common ground as well

as the differences in the respective perceptions of the two sides. It has been carefully studied by Government but no specific action on its part is called for.

Recommendations made by Indian Science Congress for checking Pollution of Environment

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECH-NOLOGY AND IN THE DEPARTMENT OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI SHIVRAJ PATIL): (a) and (b) The 73rd Session of the Indian Congress was held in Delhi during January 3-8, 1986. For the Session, the theme was "Science & Technology in Environmental Management". Based on the deliberations the Association formulates recommendations for consideration by the Government. The Association has not yet forwarded their recommendations of the 73rd Session to the Government. The recommendations, when received, will be examined by the Government for appropriate action.
