### Sector-wise outlay of Sixth Five Year Plan

Will the PRIME MINISTER be pleased to state:

(a) the Sixth Five Year Plan actual outlays Sector-wise and by how much this differs from the plan targets;

(b) the actual Sixth Five Year Plan sectoral outlays in 1980-81 prices;

(c) the Sixth Five Year Plan proposed and actual investment by the private corporate sector; and

(d) the Sixth Five Year Plan pattern of financing the plan by different methods (i) as proposed in the plan, (ii) as actually realised and (iii) in constant prices of the first year of the Plan?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND FOOD AND CIVIL SUPPLIES (SHRI AJIT PANJA): (a) and (b) A statement giving the Sixth Plan outlay, and expenditure at year to year current prices and at 1980-81 prices is attached. (See below)

(c) Against the Sixth Plan proposed investment of Rs. 19582 crores at 1979-80 prices by the Private Corporate Sector, the actual investment at current prices is provisionally estimated by CSC at Rs. 27893 crores.

(d) (i) and (ii) The pattern of financing the Sixth Plan, both as proposed and as actually realised is set out in Table 4.7 of the Seventh Plan Document which has already been laid on the Table of the House. As for (iii), there is no concept of revenues being estimated at constant prices.
