रक्षा अनुसंधान तथा विकास विभाग में राज्य मंत्री (श्री अरुण सिंह) : (क) और (ख) जी, हां । श्री वैद्यनाथ का 16-10-1985 का प्रतिवेदन श्री एच0 एन0 यादव के दिनांक 23-12-1985 के पत्र के साथ प्राप्त हुआ था । जिसमें भूतपूर्व सैनिकों ने अपने लिए स्नानगृह/शौचालय वाले मकान की व्यवस्था करने का अनुरोध किया था । श्री वैद्यनाथ को मकान खरीदने के लिए 6-11-1985 को 'वार बिरेब्ड फण्ड'' से 5,000 रु० की राश्चि पहले ही दी जा चुकी है । निम्नलिसित वित्तीय सहायता

Air and water pollution in the major cities in India

510. SHRI ASHWANI KUMAR: SHRI S. D. DHABE:

Will the PRIME MINISTER be pleased to state:

- (a) what are the levels of air, noise and water pollution in the four metropolitan cities of the country viz., Delhi, Bombay, Calcutta and Madras;
- (b) whether this level has been considered safe by the International and Indian experts; and
- (c) what short and long term steps are being taken to control further pollution and to reduce the present level?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI Z. R. ANSARI): (a) Air Pollution:

— while ambient levels of sulphur dioxide and oxides of nitrogen are within the limits, the levels of particulate matter are found to be high;

Water Pollution:

There are pockets in the metropolitan cities where the levels of water pollution are higher than the prescribed limits.

Noise Pollution:

Certain areas of the metropolitan cities with heavy traffic movement have noise levels beyond the prescribed limits.

 - tax incentives for pollution control and shifting of pollution industries from congested areas;
 - research and development of pollution control devices; and

Proposals for expansion pending Central Government from Andaman and Nicobar Island Forests and Plantation **Development Corporation**

- (a) what are the proposals for expansion pending with the Central Government from the Andaman and Nicobar Island Forests and Plantation Development Corporation and since how long; and

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI Z. R. ANSARI): (a) The Andaman and Nicobar Islands Forest and Plantation Development Corporation submitted a project report in 1980 for logging and marketing of timber and raising forest plantations and supporting natural regeneration in Little Andaman and North Andaman.

(b) The ecological aspects of the project proposals are now being studied in depth.

- (a) what is the number of jobs that have been reserved in Government vices for the physically handicapped persons and students:
- (b) what is the percentage of reservation and since when it is in force:
- (c) what is the number of persons who have been given jobs and percentage achieved in the last three years, i.e. 1983-84, 1984-85 and 1985 (till December); and
- (d) what is the reason for not achieving the target and percentages fixed?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI CHIDAMBARAM): (a) and (b) 3 per cent of the vacancies in Groups 'C' & 'D' posts servicss (1 per cent each the blind, the deaf and the orthopaedically handicapped persons) have been reserved for the physically handicapped with effect from 4th November, 1977. This reservation is applicable, in direct recruitment, to postal services identified as suitable for being held by the physically handicapped. There is no separate reservation for physically handicapped students in Government services.

- (c) and (d) As per the information available, the total number of physically handicapped persons appointed in the Government in 1983, 1984 and 1985 are 264, 182 and 89 respectively in Group 'C' posts and these figures represent 1.79 per cent, 2.55 per cent and 2.97 per cent of the total number of posts (which are identified as suitable for appointment of the physically handicapped persons) filled in the respective years.
