- (b) if so, the steps Government taking to fully equip or modernize fighting operations?

THE MINISTER OF STATE IN THE DEPARTMENT OF INTERNAL SECU-RITY (SHRI ARUN NEHRU): (a) The fire brigade was appropriately equipped to fight the fire in Siddhartha Hotel.

(b) Does not arise. However, steps are being taken to further strengthen the Delhi Fire Service and equip them with sophisticated fire fighting anad communication equipments.

  - (1) Procurement of goods and services,
  - (2) Technology Transfer of ISRO developed products,
  - (3) Technical consultancy to industries.
  - (4) Technology utilisation including specialised R & D and fabrication contracts.

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECH-NOLOGY AND IN THE DEPART-MENT OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI SHIVRAJ PATIL): (a) Yes, Sir.

- (b) A survey was undertaken by the Directorate of Industries, Delhi Administration and 1476 industries were identified as polluting industries.
- (c) Polluting and hazardous industries are being persuaded to shift from congested/residential areas. Tax incentives are provided for this purpose.
