THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. R. NARAYANAN): (a) and (b) Libya drew India's attention to US threats and imposition of economic sanctions as also to the hijacking of their civilian aircraft by Israeli Military aircraft and sought our support. We have issued statements supportive of Libya. The Nonaligned Coordinating Bureau meeting in New York at Libyan request has also issued statements which are in support of Libya.

- (b) The 94,000 stateless persons of Indian origin who had not applied for Indian citizenship when the 1964 and 1974 Agreements lapsed, are to be granted Sri Lanka citizenship. India has agreed to grant citizenship to ali eligible persons whose applications for Indian citizenship were pending, within a period of 8 months from) the date on which Sri Lanka enacts legislation for the grant of Sri Lankan citizenship to the residual numbers of stateless persons of Indian origin as indicated above.
- (c) The Government is satisfied with the outcome of the negotiations as a result

of which the issue of statelessness of persons of Indian origin in Sri lanka will be brought to an end.
