THE MINISTER OF STATE IN THE MINISTRY OF LAW AND JUSTICE (SHRI H. R. BHARDWAJ); (a) and (b) The question of enforcement of the provisions of Wakf (Amendment) Act, 1984 is still under consideration. Section 1(2) of the Act provides that the Act shall come into force in a State on such date as the Central Government may, ny notification in the Official Gazette, appoint, and different dates may be appointed for different provisions of the Act and for different States or for different areas within a State. The matter relating to enforcement of the Act was initially taken up with all the States by a letter addressed to all the Chief Secretaries. They were also requestd to take preparatory steps and be in readiness for enforcement of the Act and tne different provisions. Replies have been received from some States indicating readiness to have the Act extended; some States are vet to indicate a clear date Or their willingness to have the Act extended within a specified date. In the meanwhile Government have received several representations from the members of minority community expressing concern over some of thereof provisions contained in the Act. All these issues having a bearing on the enforcement of the Act are under consideration.

Delay in the completion of Rihand Super **Thermal Power Project**

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER (SHRI AR-IF MOHD. KHAN): (a) and (b) As per the Schedule approved by the Government of India in 1982, the first Unit of the Rihand Super Thermal Power Project (STPP) Stage-I i_s scheduled to be commissioned in June 1987. According to an assessment made in August 1985, the best achieveable date for commissioning of Unit-T i_s April, 1988.

(c) and (d) -Mjs. Northern Engineering Industries (NET) of the U.K. are the main contractors for supply and erection Ot equipment for the Rihand STPP Stage-I which is being executed with British assistance. In order to meet their contractual obligations, the NEI have to develop proper Project Engineering and M'anagement arrangements. Review Meetings were held between the National Thermal

Power Corporation and the NEI in August and September, 1985 to resolve several outstanding issues. The progress of this Project is also being closely reviewed and monitored at the Government level.
