LAM): (a) and (b) A Committee conrepresentatives sisting of to West Government Bengal. State Industrial Reconstruction Corporation India and Grindlays | Bank was constituted to consider the offers of various private parties who had shown interests in taking over the unit. The Committee came to the conclusion that the offer of Window Glass Limited was more Suitable than the other proposals. Future disposition of the Company has to be decided by Banks, Financial Institutions and the State Government.

Coal gasification process

- 1524. SHRIMATI SUDHA VIJAY JOSHI: Will the Minister of ENERGY be pleased to state:

THE MINISTRY OF ENERGY (SHRI VASANT SATHE): (a) to (d) One Low Temperature Carbonisation Plant for carbonising 1500 tonnes of raw coal per day to produce 18-20 million cft. gas per day, 990 tonnes of smokeless coke per day, 30,000 tonnes of tar per annum and other products like ammonium sulphate, calcium carbonate etc. is under construction at Dankuni in West Bengal. The gas would be supplied to industrial and domestic consumers in Calcutta.

- SHRI MUKHTIAR SINGH MALIK: Will the Minister of ENERGY be pleased to state:
- (a) whether Government's attention has been drawn to the news item which appeared in the Hindi Edition of Hindustan dated the 5th August, 1985 under the heading "DFSU KA DILLI WALLON KI ZINDAGI SE KHILWAD"; and
- = (b) if so, whether Government propose to set up a Committee to inquire into the matter and if not,, what remedial measures have been taken in regard thereto?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER (SHRI ARIF MOHD KHAN); (a) Yes. Sir.

(b) Apart from the statutory inquiries by the Electrical Inspector (Delhi Admi-

nistration) and the Departmental Enquiry by DESU, the Delhi Administration has constituted a High Level Committee for an indepth inquiry into the cases of death due to electrocution.

DESU have taken several steps to check cases of electrocution which include provision of adequate guards on overhead system (ii) removal of defects in cable feeding street light poles and boxes (iii) issue of guidelines to public.

Sikka Thermal Plant

1526 SHRI CHIMANBHAI MEHTA: SHRI MIRZA IRSHADBAIG:

Will the Minister of ENERGY be pleased to state:

- (a) whether it is a fact that Government of Gujarat has sent the project report for. Sikka Thermal Extension Unit No. in July 1983 for final sanction of the Department;
- (b) whether the clearance of the project report is pending just because the decision regarding supply of estimated 0.35 m, ton coal has not yet been taken although 2-1|2 years have passed;
- (c) would the Department expedite the decision in view of tremendous shortage of electricity supply in Gujarat; and
- (d) failing to make supply of from internal sources would the Government consider the Gujarat Government's plea for import of coal from coal producing countries?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER (SHRI ARIF MOHD. KHAN): (a) Yes, Sir. A. proposal has been submitted by the Gujarat Electricity Board.

(b) to (d) The CEA took up examination of the Scheme in consultation with the agencies concerned, including Gujarat Electricity Board. This Scheme could be techno-economically cleared by the CEA after various inputs such as coal linkage have been tied-up. The Scheme has been recommended to the Planning Commission for "in-principle" acceptance of coal linkage. The question of import of coal has not been raised for this Project.
