The major reasons for the unsatisfactory rerformance of Bharat Refractories Limited are :-

- (1) under-utilisation in the Refractory Industry due to the projected steel capacity not having come up.
- (2) due to the excess capacity in the refractory industry and sever competition the prices quoted by some of the smaller refractory manufacturers are lower than the prices prevalent in earlier
- (3) increase in the cost of like electricity, raw material etc.

Increase in the amount of depreciation and interest from Rs. 4.56 crores in 1982-83 to Rs. 8.70 crores in 1983-84 and Rs. 8.62 crores in 1984-85.

- (e) The steps proposed to be taken to bring about improvements in the working of Bharat Refractories Limited are:-
  - (1) As the installed capacity of Bharat Refractories Limited is in excess of the demand, steps are being taken to increase the production of higher value refractories in a phased manner so that capacity utilisation improves as the sales realisation.
  - Limited is (2) Bharat Refractories entering into foreign collaborations in order to produce higher value added refractories to meet the emerging demands of the steel plants.
  - (3) A provision has been made in the Seventh Five Year Plan for the modernisation of Bharat Refractories Limited.

The Maharashtra Tourism Development Corporation has provided Rs. 2.50 lakhs each for the development of a tourist complex at Sevagram and Paunar in the State Government's 7th Five Year Plan to meet the requirements of the visiting tourists.
