JJ

(c) and (d) In addition to Rs. 25 lakhs granted for the purpose in 1983-84, Government of India sanctioned Rs. 35 lakhs in 1984-85 and Rs. 25 lakhs in 1985-86 bringing the total amount sanctioned to Rs. 85 Jakhs against the estimated cost of Rs. 130 lakhs.

Agartala Aijwal, Lilabari, Zero; Daporijo, Dibrugarh and Passighat.

(c) While the five Dorniers already in the fleet of Vayudoot the based at Bombay (1), Calcutta (1), Delhi (3) and Hyderabad (1), the base of

the other Dorniers will be decided taking into account the operational requirements.
