THE MINISTER OF STATE IN THE DEPARTMENT OF CIVIL AVIATION (SHRI JAGDISH TYTLER): (a) Extension and modification of terminal building strengthening of runway and associated pavements, augmentation of water and

power supply and construction of residential quarters and barracks for security staff have been included in the draft Seventh Five Year

- (b) Construction of operational wall and compound wall, angmentation of water and power supply improvement of staff amenities and extension and modification of terminal building were included in the Sixth Five Year Plan. In the Revised Estimates 1984-85, a provision of Rs. 9.20 lakhs was wade for these works.
- (c) No, Sir, Works which pertained to stall amenities were undertaken during the year, 1984-85, at an estimated cost of Rs. 4.20 lakhs. However, aew work of extension and modification of terminal building for which a provision of Rs. 5 lakhs was made in the year 1984-85, could not be started.
- (d) Extension and modification of ter minal building was not included in the original Sixth Five Year Plan. Permis sion for its inclusion was received fromi the Planning Commission in November, 1984. Therefore, the work could not be started in the financial year 1984-85.
