manufacture of the distress signals were:

The Mercantile Marine Department, Tuticorin, while issuing the certificate recommended that these pyrotechnics be renewed at the earliest. However, this does not appear to have been done. Normally, these pyrotechnics are considered to be in good condition for a period of three years from the date fo manufacture. The matter is under investigation by the Metropolitan Magistrate.

It is confirmed that Maini Shipping Company had written to the relatives of the crew of M. V. Nitya Nanak that the vessel may have been delayed due to bad weather. This matter has also been the subject matter of investigation under Section 36C of Merchant Shipping Act.

## Ban on recruitment in Railways

(a) Yes, Sir. Parts of the cowling of one engine fell off without causing any operational problem to the aircraft. The engine was replaced in Hongkong.

(b) and (c) The incident is under investigation.

## Refrenchment of cargo handling workers at Paradip Port

- (a) whether Government are aware that the Chairman of Paradip Port Trust arbitrarily introduced mechanical system in coal loading in Paradip Port on the 8th October, 1985, which was being done by unlisted cargo-handling workers since long through C&F Agents Stevedores;
- (b) whether the introduction of mechanical system has thrown out of job about 1550 unlisted cargo handling workers.
- (c) whether it is also a fact that the Chief Minister of Orissa advised the Chairman of the Paradeep Port
