views that Unesco should strive for greater programmes. concentration in less politicisation in its activities and more efficient management of its activities and economies in expenditure. The demands for such reforms in Unesco were also made following the notice of withdrawal given by USA in December, 1983. The Director-General of Unesco, in response to these demands, had set up working groups to consider measures for improving the functioning of the Organisation. A Temporary Committee had' also been set up by the Executive Board of Unesco for improving the functioning of the Organisation. The recommendations of the Committee and the working groups were accepted by Director-General and the Executive Board and appropriate action was initiated on these recommendations wherever feasible. While several measures for improvement were incorporated in the Draft Programme and Budget for 1986-87, other recommendations requiring further approval were considered at the Twenty-third session of the General Conference of Unesco. The General Conference endorsed the reforms and also adopted the Programme and Budget fox 1986-87.

Family Welfare Programme in Karnataka

. 1828. SHRI SURESH PACHOURI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

 (a) whether the progress of family welfare programme is poor in the urban areas of Karnataka and very successful in rural areas;

(b) whether over all performance of the State of Karnataka in the field is better than other States;

(c) whether Karnataka achieved 45 per cent progress within six months this year as against 60 per cent progress for the whole year for the last year;

(d) what is the position of other States regarding family welfare programme;

(e) what are the directive being issued to other States; and

(t) whether any information has been obtained from the State Governments?,

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI KRISHNA KUMAR): A The progress of family welfare programme in Karnataka in Rural areas is better than that in Urban Areas.

(b) to (d) The State-wise and method-wise target and achievements during the last year *viz.* 1984-85 and the State-wise, methodwise proportionate target and achievements for 1985-86 (April to September) are given in statements I and II [See Appendix CXXXVI, Annexure Nos. 31 and 32].

(e) and (f) Information contained in the statements is based on the monthly reports being obtained from various States. Programme performance varies from State to State. However, all the States have been urged upon to improve their performance which is regularly monitored, appraised and appropriate feed back sent to them.

Vapi-Karambeli rail bridge

1829. DR. BAPU KALDATE: Will the Minister of TRANSPORT be pleased to, state:

(a) whether it is a fact that due to leakage and overflow of Damanganga Dam in Gujarat, the Vapi-Karambeli railway bridge was washed away;

(b) if so, what are the details thereof; and

(c) what steps have been taken to restore the bridge for rail traffic?

THE MINISTER OF STATE IN THE DEPARTMENT OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) The Railway bridge over the Damanganga river between Vapi and Karambeli stations was washed away on 31.7.1976 due *to* very heavy rains and unprecedented floods and not due to leakage or overflow of the Damanganga Dam.
