(d) if so, what steps Government propose to take to re-employ the retrenched workers and save the port from labour trouble?

THE MINISTER OF TRANSPORT (SHRI BANSI LAL); (a) Due to lightening strike by cylearing and forwarding workers from 3-10-1985, the clearing and forwarding operations hi Paradip Port were paralysed. As a result, M/s. SAIL and TISCO could not move imported coking coal to their steel plants and this caused an alarming situation at their steel plants threatening their closure as coal stocks in the mills had become critically low. Hence, both M/s. SAIL and TISCO requested Paradip Port Trust to arrange for loading of coking coal into wagons and trucks by mechanical means. Accordingly, mechanisation of coal loading has been introduced in Paradip Port from 8th October-, 1985.

- (b) No, Sir.
- (c) The Chief Minister had taken a meeting with the President, Paradip port and Dock Mazdoor Union and Chairman, Paradip Port Trust On 10th September, 1985 to discuss the outstanding,' problems of the clearing and forwarding workers of Paradip Port. The Chief Minister had desired that the Paradip Port Trust authorities may agree to scrutinise the list of about 1800 workers, which ihe Union claimed was once submitted to the Port authorities but out of which only about 1479 workers were issued gate passes once again, and such of the workers, not exceeding 332, who were found to have worked in the port, in the past, may be issued

2 passes.

In pursuance of the above decision, the Chairman, Paradip Port Trust have informed that the Union could not produce any proof of these workmen having worked in the Port to consider the request for issuing entry passes to them.

(d) The question does not arise as there has been no retrenchment on account of mechanisation of coal loading.

Indian Council of Medical Research Report on T.B. cholera typhoid and polio

THE DEPUTY MINISTER IN THE DEPARIM1N1 OF FAMILY WELFARE (SHRI KRISHNA KUMAR): (a) and (b) The Indian Council of Medical Research have received a study report from an Investigator in receipt of a study grant from Indian Council of Medical Research in which iome shortcomings in the health education programme in three states have been highlighted. The Indian Council of Medical Research are yet to appraise the report, the methodology used and the validity of the conclusions drawn. It is, therefore, premature to consider taking any action.

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI KRISHNA KUMAR): (a) to (c) Yes Sir. The following supplementary feeding programmes for pre-school children are implemented by the Government of India in an attempt to bridge the calorie gap observed in their home diets:

Ministry of Welfare;

- (1) Balawadi Nutrition Programme
- (2) Special Nutrition Programme.
- (3) Integrated Child Development Services Scheme.

Ministry oft Human, Resourcesn

(4) Mid-day meal programme in primary schools.

In addition the Ministry of Food and Civil Supplies is involved in several projects to improve the nutrition situation ia the country:—

- (1) Development of low cost weaning foods for supplementary feeding;
- (2) Education, extension and publicity activities;
- (3) Fortification and enrichment programmes such a_s salt with iron; Sago with proteins, vitamins and minerals and with Vitamin 'A'.

The Ministry of Health and Family Welfare has launched the following intervention programmes;

- (1) Prophylaxis programme to prevent nutritional anaemia in mothers and chil dren;
- (2) Prophylaxis programme against blindness due to Vitamin A deficiency;
 - (3) National Goitre Control Programme.
