THE MINISTER OF STATE IN THE DEPARTMENT OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Rs. 9.00 crores.

(b) Out of the total route length of 144 route kilometres, section Arakko-nam-Katpadi-Gudiyattam (86 route kilometres) have been electrified so far.

(c) The likely date for electrification of the whole track is 31.3.1986.

(d) and (e) Out of the three traction substations on this section, one at Thi-ruvalam has already been commission-ed. The Railway's portion of work at Valathoor traction sub-station has been -completed but this sub-station will be commissioned only after Tamil Nadu Electricity Board erect their transmission line over a stretch of 14 KMg in the reserve forest area for which clearance from Ministry of Environment and Forest is awaited. The Railway traction sub-section at Tirupatter will be completed by 31.12.85 and will be commissioned by 31.12.86 on completion of the woxks by Tamil Nadu State Electricity Board.

Unani and Ayurvedic Medical Institutes in the Country

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI KRISHNAKUMAR): (a) No Unani and Ayurvedic Medical Institutes are being run and maintained by this Ministry directly. However, Natioal Institute of Ayurveda, Jaipur an autonomous body is totally funded by the Central Government.

(b) Under the Seventh Five Year Plan, a National Institute of Unani Medicine, is being set up by this Ministry at Bangalore.

(c) In the Central Government Health Scheme there are 11 Unani physicians and 65 Ayurvedic Physicians.
