Closing Down of Units of C.S.I.R. Due to Import of Technology

*253. SHRI INDRADEEP SINHA SHRI SURAJ PRASAD:

Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that 40 units of Council of Scientific and Industrial Research are likely to be closed down due to import of technology;
- (b) whether it is also a fact that the Bharat Heavy Electrical Limited is importing anti-corrosion technology discarding its own;
- (c) whether a number of small scale industries are likely to be closed down due to indiscriminate inport of technology; and
- (d) what remedial measures Government are taking in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI SHIVRAJ PATIL): (a) No, Sir.

- (b) Bharat Heavy Electrical Limited has entered into a technical collaboration agreement with M/s Harco Corporation, USA for technology transfer of Cathodic Protection System. This system is mainly used for providing corrosion resistance to gas and oil pipelines. This technology, in totality, is not available in the country.
- (c) No, Sir. Import of technology is not indiscriminate but in line with the declared objective of the Government to upgrade technology in all sectors including the small scale sector.
 - (d) Does not arise.

Interpol Action Against Terrorism

*254. SHRI K. VASUDEVA PANICHAR SHRIMATIKRISHNA KAUL:

Will the Minister of Home AFF-AIRS be pleased to dtate:

- (a) whether Government's attention has been drawn to the news item appearing in the Indian Express of the 27th October, 1985 under the caption 'Interpol decides to curb terrorism, if so, what are the details thereof; and
- (b) what are the steps Government have taken to have a proper Liaison with the Interpol in this regard?

MINISTER OF HOME AFFAIRS (SHRI S. B. CHAVAN) : (a) and (b) In the General Assembly Session of the Interpol, it has been decided to prepare a manual containing instructions for fighting terrorism and to put international terrorism as an item on agenda for discussion in all the Regional Conferences to be held in future. It was also decided to organise a Symposium to discuss the role of Interpol in fighting international terrorism. The Central cau of Investigation is keeping close liaison with the Interpol in this regard.

विज्ञान श्रीर शौद्योगिकी मंत्रालय तथा महासागर विकास, परमाणु ऊर्जा, इलेक्ट्रानिकी और अन्तरिक्ष विभागों में राज्य मंत्री (श्री शिवराज पाटिल): (क) हाल ही में, इलेक्ट्रानिकी के विज्ञास को बढ़ावा देने की दृष्टि से नीति-विषयक एकमुश्त उपामों की घोषणा की गई है।

(ख) मरशार इलेक्ट्रानिकी उद्योगों की स्थापना के लिए सम्पूर्ण देश के किसी भी अनुमन क्षेत्र में प्रोत्साहन देती है। राजस्थान राज्य के लिए कोई विशेष उपाय नहीं किये जा रहे हैं। राज्य सरकार ऐसे उद्योगों की स्थापना करने में सहायक परिस्थितियां उत्पन्न करने का प्रयास करती है। जब कभी श्रावश्यकता पड़ती है तो इलेक्ट्रानिकी विभाग श्रावश्यक मार्गदर्शन प्रदान करता है।

Provision of Sophisticated Weapons and Be⁺ter Facilities for Delhi Police

*256. SHRI HARVENDRA SINGH HANSPAL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) what specific steps are being taken to provide the Delhi Police with sophisticated weapons and requisite facilities to make it more effective and mobile in the light of high incidence and nature of crime in Delhi; and
- (b) whether Government are considering increase in strength of the Delhi Police and providing better training facilities to them?

THE MINISTER OF HOME AFFAIRS (SHRI S.B. CHAVAN):
(a) A Statement is laid on the Table of the House,

(b) on the recommendations of the Shrivastava Study Group 4,814 additional posts have been sanctioned for the Delhi Police. The existiing Police Training School is being upgraded and equipped with up-todate modern training facilities.

Statement

Delhi Police is being equipped with sophisticated and modern equipment and weapons in order and make it more effective. In addition, the following steps have been taken to make it more responsive and mobile:—

- 1. Delhi Police Zones have been increased from 6 to 9. Each zone will be looked after by a Deputy Commissioner of Police.
- 2. 37 new police stations will be opened on the next three years. With these additional police stations Delhi will have 100 Police Stations by 1988 as against 63 at present.
- 3. Mobility of th Police force has improved; and Inspectors and 50% Sub Inspectors in the Special Branch will be Provided with Motor Cycles.
- 4. 118 additional patrol carsha ve been sanctioned. These will be equipped with wireless communication and controlled by the Police Control Room. For this Purpose staff of 1923 personnel have been sanctioned.
- 5. A Special Cell to deal with crime against women has been sanctioned with the staff of 44, which will work under a Deputy Commissioner of Police.
- 6. Proposals for improvement of the Traffic Branch and an increase in the strength of vehicles in the Delhi Armed Police have also been a sanctioned.
- 7. A Post of Additional Commissioner of Police (Training) has been created in Delhi Police.
