Invitation of Prime Minister to ENLF Leaders

1900. SHRI : BHAGATRAM MANHAR : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether after the breakdown of second phase of the Thimpu talks between Sri Lanka Government and the Eelam National Liberation front Leaders, the Prime Minister invited the ENLF leaders for talks; and

(b) if so, what was assessment of the situation as given by them what was the outcome of the talks ?

THE MINISTER GF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT) :
(a) Yes Sir. Three rounds of talks with ENLF leaders have been held in New Delhi since the adjournment of the Thimpu Talks.

(b) The ENLF leaders stated that violations of the cease-fire by Sri Lankan security forces were continuing and that the Sri Lankan proposals for a political solution did not meet their expectations.

ENLF appreciated India's efforts towards a political solution and

there was agreement on all sides that India should continue with these efforts.

Public Sector Outlay Plan

1901. SHRIMATI KANAK MUKHERJEE : Will the PRIME MINISTER be pleased to state :

(a) the total public sector outlay at current as well as at 1979-80 prices during the Sixth Five Year Plan ;

(b) what was the investment by the private sector; and

(c) the details about the financing of the public sector outlay ?

THE MINISTER GF STATE IN THE MINISTRY OF PLANNING (SHRI AJIT KUMAR PANJA): (a) The total final public sector outlay of the Sixth Five Year Plan is Rs. 1,10,821 crores at current prices. This includes Central assistance to States for relief against natural calamities of Rs. 1175 crores. This Public Sector outlay estimated at 1979-80 prices, comes to Rs. 76,677 crores.

(b) Estimated investment by the private sector at current prices during the first four years 1980-84 of the Sixth Five Year Plan is Rs. 80,014 crores. This is based on the provisional estimates upto 1982-83 and quick estimates for 1983-84 as released by the Central Statistical Organisation.

(c) The details about the financing of the Public Sector Outlay of Rs. 1, 10,821 crores in the Six Five Year Plan are indicated in the Statement attached.

Sanctioning of West Bengal projects

1902. SHRIMATI KANAK MUKHERJEE : Will the PRIME MINISTER pleased to state :

(a) whether it is a fact that not a single West Bengal project has

been rejected but have only been postpone due to financial constraints; and

(b) if so, by when the West Bengal projects like new railway lines Haldia ship repairing project, Durga-pur truck manufacturing project, etc. are expected to get clearance from the Centre ?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI AJIT KUMAR PANJA) (a) Details of the outlay of expenditure under the Sixth Plan of West Bengal are given in the Statement I enclosed.

The reviews of the State Plan which were undertaken jointly with the state Government at the time of formulation of the successive Annual Plans, have revealed that the expenditure has fallen short mainly because; the State Government had not been able to mobilise own resources to the extent envisaged in the Plan. The expenditure would have been still less of additional Central assistance of Rs. 81.89 crores and medium-term loans of Rs. 414.43 crores were not given by the Central Government over and above its original commitments.
