

Guidelines of ratio parameters for valuing Bulk Drugs

2211. SHRI PRAVIN KUMAR PRAJAPATI: Will the Minister of INDUSTRY be pleased to state:

(a) whether any guidelines have been issued for the working of ratio parameters in regard to ex-factory value of production of bulk drugs and formulations;

(b) whether it is a fact that companies inflated the ex-factory values of production of bulk drugs and under valued the ex-factory values of formulations;

(c) what are the names of the companies whose cases came to Government's notice;

(d) what are the names of the companies who still do not fulfil the ratio parameters; and

(e) what are the details of drugs produced by Astra-IDL and Fairdeal Corporation along with the production during the last three years, year-wise as well as ex-factory value of each drug taken for the computation of total ex-factory value of production of bulk drugs by each company?
