Selling Price of formulations by Pfizer

2202. SHRI NAND KISHORE BHATT: Will the Minister of INDUSTRY be pleased to refer to the answer to Unstarred Question 186 given in the Rajya Sabha on the 18th November, 1985 and state:

- (a) what are the prices at which Pfizer is selling their formulations based on Oxytetracycline and its salts;
- (b) since when the company is selling these formulations at their own prices;
- (c) what are the grounds on which Pfizer challenged the fixation of prices by Government;
- (d) what was the sales turn over of Pfizer for these formulations during the last three years, year-wise and what is the percentage of sales of these formulations to total sales turn over during the same period;
- (e) whether it is a fact that this drug bas been categorised as essential; and
- (f) if so what is the mark up allowed on formulations and what mark up is enjoyed by the company?

THE MINISTER OF STATE IN THE DEPARTMENT OF CHEMICALS AND PETROCHEMICALS (SHRI R. K. JAICHANDRA SINGH); (a) to (c) M|s. Pfizer are selling the Oxytetracycline formulations based on the decision of the Delhi High Court. The main ground on which the prices of bulk drug Oxytetracyline and its salts and the formulations based thereon were challenged is that the material based on which prices were fixed revised were not disclosed to them.

(d) Sales turnover of formulations is not monitores.

- (e) Oxytetracyline and its salts are specified under category II of Drugs (Prices Control) Order, 1979.
- (f) The mark up allowable under the Drugs (Prices Control) Order, 1979 is 55 per cent. It is difficult to say what is the mark-up in the present prices charged by the Company, as the prices were declared under Drugs (Prices Control) Order, 1970.
