Poverty line

2525. MISS SAROJ KHAPAR-DE: Will the PRIME MINISTER be pleased to state:

- (a) what is the per capita monthly expenditure level in ascertaining poverty line in rural and urban areas respectively; and
- (b) what is the minimum earning required by a citizen per month to remain above poverty line?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI AJIT PANJA) : (a) For ascertaining the poverty line at 1984-85 prices, the per capita monthly expenditure level has been estimated to be Rs. 107 in rural areas and Rs. 122 in urban areas and this updated poverty line has been used in the Seventh Five Year Plan. The basis of determining the poverty line is the report of the "Task Force on Minimum Needs and Effective Consumption Demand," Planning Commission. According to this report, the poverty line is the per capita monthly expenditure level of Rs. 49.09 in rural areas and Rs. 56.64 in urban areas at 1973-74 prices, corresponding to the calories requirements of 2400 per capita per day in rural areas and 2100 per capita per day in urban areas. This poverty line is up-dated for recent years by using the Central Statistical Organisation Private Consumption Deflator (as a proxy for rise in the price of the consumption basket).

(b) No specific target has been fixed in the Seventh Five Year Plan regarding the minimum earning per month required by a citizen to remain above poverty line. However, the person's monthly earning should be Development of Tourism, Establishment of Ecology

sufficient enough for him to spend at least Rs. 107 per month in rural areas and Rs. 122 per month in urban areas at 1984-85 prices, so as to enable him to remain above poverty line.
