(ख) विषैली गैस रिसने से संबंधित तथ्यों ग्रौर गैस रिसन के परिणामस्वरूप जीवन प्रणाली पर पड़ने वाले प्रभावों के कुछ पहलुग्रों पर वैज्ञानिक खोज कर रही संस्थानों द्वारा इन निर्देशनों का पालन किया जा रहा है । न्यायालयों में कानूनी मामलों के रूके होने के कारण ग्रौर वैज्ञानिक खोजों से पूर्व ग्रपरिक्व वक्तव्यों को टालने की दृष्टि से यह गोपनीयता ग्रावश्यक है ।

(ग) खोजों के पूर्ण होने से पूर्व सम्मति के परिणाभस्वरूप भ्रान्ति टालने के लिये उपाय विशेष रूप ये लाभदायक समझे जाते हैं।

## Review of Freight Equalisation Policy

2475. SHRI NIRMAL CHATTERJEE : Will the PRIME MINISTER be pleased to state :

(a) whether the policy of freight equalisation for iron and steel, the telescopic freight rate for movement of coal, in the absence of similar measures ki other vital industrial inputs have affected the industrial growth in the eastern region, particularly in West Bengal;

(b) whether there is any likelihood of any rt vie w of the said policy soon;

(c) if so, the time by when a review is likely to be made ; and

(d) if the reply to part (b) above be in the negative, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI AJIT PANJA): (a) It is difficult to attribute industrial growth in a particular region/ State to freight equalisation policy. The telescopic freight structure applies to the movement of all cornmo-ditks by rail including coal.

(b) to (d) The National Transport Policy Committee, having wider terms of reference, examined 60

\*he issue of fricght equalisation and endorsed the view that freight equalisation in industrial commodities did not meet the desirable objective of dispersal of economic activity. The Committee submitted its report in 1980 and recommended that existing schemes of freight equalisation be phased out gradually. The Government have already principle, agccepted, in the recommendation of this Committee to phase out gradually the existing freight equalisation scheme in respect of goods like steel and cement subject to subsidisation of transport for remote, inaccessible and isolated areas. Phasing out of freight equalisation will have to be done over a suitable period of time so that the industries concerned have sufficient time for adjustment in the prices. Modalities and time phasing of withdrawal of the freight the equalisation scheme in respect of iron and steel have not yet been finalised. No proposal for review of the telescopic freight structure for coal is envisaged.
