

Broad details of these Letters of Intent, Industrial Licences and Registrations are being regularly published in the Monthly Newsletter brought out by the Indian Investment Centre, copies of which are available in the Parliament Library.

(c) and (d) The emphasis in the Seventh Five Year Plan is laid on maximising the utilisation of the existing facilities through improved productivity, upgradation of technology, modernisation etc. Accordingly, suitable provisions have been made in the Seventh Five Year Plan for the important/continuing projects/schemes in the State of Andhra Pradesh including Vizag Steel Plant, Sponge Iron India Ltd., Hindustan Zinc Ltd. (Vizag Smelter Expansion, Mercury, Silver recovery, modernisation etc.), Ramagundam Fertilizer Project (Revamping and Rehabilitation), Cement Corporation of India's Plant at Tendur and Yeraguntala, Hindustan Organic Chemicals (PTFE), Second Phase Expansion of IDPL Hyderabad, Tyre Corporation's Unit at Kakinada, Hindustan Cables Ltd., BHEL Hyderabad (Mill Accessories Project, modernisation, renewal and replacement, manufacture of gas turbines), HMT Hyderabad (Lamps Division diversification, renewals, replacement etc.), BHPV, Hindustan Shipyard, Visakhapatnam Manuguru Heavy Water Project, Nuclear Fuel Complex, Electronics Corporation of India Ltd., Singrani Collieries Security Press, Hyderabad and Indian Government Mint, Hyderabad. A Propylene Recovery Unit is also proposed to be taken up by HPCL in Andhra Pradesh during Seventh Five Year Plan. It is also proposed to set up a Regional Extension Centre CIPET, in Andhra Pradesh.

Setting up of High Court Bench at Rajkot

Will the Minister of LAW AND JUSTICE be pleased to state:

(a) whether there is any demand for setting up High Court Benches at Rajkot and other parts of Gujarat since long;

(b) if so, the details thereof;

(c) what action has been taken to open the High Court Bench so as to fulfil the demands of the people of Gujarat;

(d) whether the Gujarat Government has written to Central Government at any time in this regard; and

(e) if so, the details thereof and the action taken by the Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF LAW AND JUSTICE (SHRI H. R. BHARDWAJ): (a) and (b) An Hon'ble Member had proposed in May, 1981, the establishment of a High Court Bench for Saurashtra region. Demands have been made to the Government of Gujarat by MLAs and Bar Associations etc., for establishment of Benches at Rajkot, Surat and Baroda.

(c) to (e) The Government of Gujarat have sent copies of Resolutions regarding the Commission consisting of Shri D. G. Palekar, a retired Judge of the Supreme Court of India, appointed to study the demands received from various places in the State for a Bench of the High Court of Gujarat and to advise the State Government.

The Central Government has not received any proposal from the State Government in this regard so far.

THE MINISTER OF STATE IN THE
DEPARTMENT OF INDUSTRIAL DE-

LAM): (a) to (d) Government of India
have no proposal to set up a unit to
manufacture tyres and tubes in the State
of Orissa. However, M/s. Kesoram Indus-
tries & Cotton Mills Ltd., Calcutta, have
been granted permission to set up a new
automotive tyre and tube unit in District
Balasore, Orissa.

Raising capacity utilisation of cement In- dustry by National Productivity Council

DWAJ: Will the Minister of INDUSTRY
be pleased to state:

(a) whether the National Productivity
Council has developed new norms so as
to raise the capacity utilisation in the Ce-
ment Industry by 8 to 10 per cent; and

(b) if so, what was the capacity utiliza-
tion in this industry in 1983-84 and
1984-85 and what are the new norms de-
veloped by the NPC?

THE MINISTER OF STATE IN THE

LAM): (a) and (b) The National Pro-
ductivity Council (NPC) has evolved pro-
ductivity norms for measuring and moni-
toring productivity of various inputs con-
sumed by the cement industry in the
areas of capacity utilisation, energy con-
sumption, grinding media consumption,
