(b) to (d) As on 30-11-1985, 32 posts of Chief Executives and 30 posts of Functional Directors were vacant. Recruitment action has already been initiated to fill up the existing vacancies except in those cases where the post have been kept in abeyance pending consideration of re-organisation of some public enterprises.

As per existing policy, these appointees are given an initial tennure of two years and subject to their satisfactory performance, their tenures are further extended upto a period of five years with the condition that the extended tenure will not go beyond their date of superannuations.

Government also keeps a close watch on the vacancy position and initiates advance action wherever possible to expedite selection. Among the other steps taken in this regard, mention may be made of the systematic holding of interviews by the Public Enterprises Selection Board (PCSB) which meet normally twice a week for this purpose.

Measures for preventing industrial units

2664. SHRI CHIMANBHAI MEHTA: Will the Minister of INDUSTRY be pleased to state:

- (a) what measures Government propose to take regarding prevention of industrial units going sick; and
- (b) what are the latest figures of sick industrial units, large, medium and small, and scheduled banks capital locked in those units, and number of unemployed labour because of the sickness of the units?

THE MINISTER OF STATE IN THE DEPARTMENT OF **INDUSTRIAL** DEVELOPMENT (SHRI M. ARUNA-CHALAM): (a) To deal with the problem of industrial sickness in the country, Government have issued certain policy guidelines for guidance of Central Ministries, State Governments and Banks and Financial Institutions in October, 1981. The salient features of

these guidelines were furnished in reply to Rajya Sabha Unstarred Question No. 700 on 15-7-1982.

Also the bilt viz. The Sick Indus-Companies (Special Provisions) Bill 1985' has been passed by the Lok Sabba on 9th D. cember, 1985 which provides, inter-alia for timely detection of sick and potentially sick industrial units and for establishment of a quasijudicial body to be designated as the Board for Industrial and Financial Reconstruction with powers to consider suitable remedial measures for speedy rehablitation of potentially viable sick industrial anits.

(b) Data on sick industrial units assisted by banks are collected by the Reserve Bank of India as per the definition of sickness adopted by it. As per the latest data furnished by it, the number of sick units and the amount outstanding against these units as on 31st December, 1984 (Provisional) are shown below:
